The original resolution had been modified by the CDA Policy Development Council and was approved with the following language.

“**RESOLVED**, THAT IT IS APPROPRIATE AND IMPORTANT FOR DENTISTS TO SCREEN PAIENTS FOR SIGNS AND SYMPTOMS OF SLEEP DISORDERED BREATHING AND TO WORK WITH PHYSICIANS TO DIAGNOSE AND TREAT SLEEP DISORDERED BREATHING; BE IT FURTHER,

RESOLVED THAT CDA SUPPORTS INCREASED AWARENESS AND THE EDUCATION OF DENTAL PROFESSIONALS ON APPROPRIATE INVOLVEMENT IN THE SCREENING, DIAGNOSIS AND TREATMENT OF SLEEP DISORDERED BREATHING; AND BE IT FURTHER,

RESOLVED THAT CDA SUPPORTS EFFORTS AT THE FEDERAL AND STATE LEVELS TO

ENSURE DENTISTS ARE RECOGNIZED MEMBERS OF THE HEALTH CARE TEAM MANAGING SLEEP DISORDERED BREATHING, AND TO ENSURE THAT PATIENTS' HEALTH CARE BENEFITS ARE MAINTAINED REGARDLESS OF WHETHER A DENTIST OR PHYSICIAN PROVIDES PATIENT CARE.”

11/7/14 Brought to the California Board of Dental Examiners concerns about patient risks of oral appliance therapy treatment for sleep disordered breathing by non-dentists and dentists without specific training in sleep disorders.

11/14-11/15/2014 Submitted two new resolutions on dentists treating Sleep Disordered Breathing to the CDA House of Delegates. Both were approved for referral to appropriate CDA entity for further evaluation.

Oct 2015 Submitted new resolution regarding dentistry's involvement with sleep disorders in California

Nov 2017 Resolution 14- 2017-H, Later School Start Times: submitted by Dr. Michael Simmons delegate was defeated by a vote of 130 (70%) opposed to 55 (30%) in favor:

November 2023 HPV - resolution authored, submitted and adopted by the CDA house of delegates

November 2025 House resolutions rejected by the speaker - Dental Homes before Age 1. Developing Policy for California Dentists treating Snoring without OSA.

Political Action - California State Legislature

Although CDA Resolution 14-2017-H was not passed by the CDA house in 2017, the State of California signed into law senate bill 328 (SB328) on October 13, 2019, making California the first U.S. state to make delayed school start times the law. Dr. Simmons was a very small contributor to the success of this bill.

Political Action - American Dental Association

Author (co-author Dr. Keith Thornton) of the American Dental Association Resolution AB17 in 2015 calling for the ADA to determine scope of dentists in treating Sleep Related Breathing Disorders. This resolution was presented by Texas delegation leader Dr. Bill Gerlach and received unanimous approval.

Resolved, that the American Dental Association develop policy as to dentistry's role in Sleep Related Breathing Disorders (SRBD), and be it further

Resolved, that the American Dental Association designate the appropriate agency to develop suggested guidelines as to the dentist's role in airway management, and be it further

Resolved, that the designated agency report to the ADA House of Delegates at the 2016 Annual Session with recommendations for dentists' involvement in SRBD.”

This unanimously passed ADA resolution resulted in the ADA publication of “The Role of Dentistry in the Treatment of Sleep Related Breathing Disorders” that was adopted by ADA's 2017 House of Delegates. Specifically, the ADA House of Delegates approved an American Dental Association (ADA) policy statement October 23, 2017 addressing dentistry's role in sleep-related breathing disorders (SRBD), as a direct result of Dr Simmons and Thornton's 2015 resolution.

Political Action - American Dental Association

Ongoing resolutions written and submitted to the California dental association on sleep medicine and dental education extending for over 15 years.

Two resolutions written in 2022 discussed at the CDA House resulted in one resolution referred to the appropriate CDA entity to determine if CDA dentists have the authority to prescribe or dispense Home Sleep Apnea Testing.

Three resolutions written in 2023 for the CDA House. Passed resolution on Dentists engagement in HPV screening and vaccinations, and two resolutions found out of order (addressing Clarification of Scope of Dental Practice and Dentists Diagnosing and Treating OSA).
